Following to the communications dated 26 July 2019 (Registry No. 280677) and 31 August 2022 (Registry No. 18086) regarding the current liquidity agreement with JB CAPITAL MARKETS, SOCIEDAD DE VALORES S.A. (the “Liquidity Agreement”), which is temporarily suspended, with effect from March 28, 2023, as a consequence of the establishment by the Company of a Buy-Back Programme of its own shares, as communicated on March 28, 2023 through Inside Information (Registry No. 1815), and in accordance with the provisions set forth in Rule Fourth, limb 2, b) of Circular 1/2017 of 26 April, of the Spanish National Security Market Commission (*Comisión Nacional del Mercado de Valores*) on liquidity contracts, a summary of the operations carried out under the aforementioned Liquidity Agreement for the first quarter of the fiscal year of 2023 (since 1 January 2023 until 28 March 2023) is hereby included:
