OTHER RELEVANT INFORMATION

Following the announcement of Inside Information published on March 28, 2023 (registration no. 1815), regarding the buy-back programme for the repurchase of own shares approved by PRISA's Board of Directors (the "**Buy-back Programme**"), pursuant to the authorization granted by the ordinary General Shareholders' Meeting of the Company, held on June 28, 2022, under item ten of the agenda, PRISA announces the end of the Buy-back Programme as today (September 29, 2023) is the last day of validity of the same.

Likewise, in accordance with Article 5 of Regulation (EU) No 596/2014 of the European Parliament and of the Council of 16 April 2014 on market abuse, and with Articles 2.2 and 2.3 of Commission Delegated Regulation (EU) 2016/1052 of 8 March 2016, PRISA announces that, during the period between 27 September 2023 and 29 September 2023 (both included), the Company has carried out the latest transactions on its own shares under the Buy-back Program, which are detailed below in aggregate form:

After the last of the aforementioned acquisitions, the total number of own shares acquired under the Buyback Program has amounted to 4.421.714 shares of Prisa, representing approximately 0,439 % of the Company's share capital as of the date of this communication, and the total monetary amount invested by the Company for the acquisition of said shares has amounted to 1.689.208,54 euros (including brokerage fees and commissions paid); all of this through the execution of the transactions that have been periodically communicated to the market, in accordance with the provisions of the applicable regulations, through the corresponding communications of "other relevant information" published weekly from April 4, 2023 until today with this communication.

As also reported through the communication of Inside Information published on March 28, 2023 (registration number 1815), as a consequence of the establishment of the Buy-back Program, with effect from March 29, 2023, was temporarily suspended the liquidity contract signed with JB Capital Markets, Sociedad de Valores, S.A.U., (the "Liquidity Contract") initially signed in July 2019 (communicated to the market through the publication of the corresponding "relevant fact" registration number 280677) and which has been extended by agreement between the parties successively, the last in July 2023 (effective until July 11, 2024), communicated on July 17, 2023 (registration number 23629). In this sense, PRISA informs of the resumption of the Liquidity Contract, once the Buy-back Program has ended, that is, with effect from October 2, 2023.
