Regarding the liquidity contract signed with JB Capital Markets, Sociedad de Valores, S.A.U., (the “**Liquidity Contract**”) initially signed in July 2019 (communicated to the market through the publication of the corresponding “relevant fact” registration number 280677) and which has been extended by agreement between the parties successively, the last in July 2024 (effective until July 11, 2025), communicated on July 2, 2024 (registration number 29498), and in accordance with the provisions set forth in Rule Fourth, limb 2, b) of Circular 1/2017 of 26 April, of the Spanish National Security Market Commission (*Comisión Nacional del Mercado de Valores*) on liquidity contracts, a summary of the operations carried out under the aforementioned Liquidity Contract for the fourth quarter of the fiscal year of 2024 (since 1 October 2024 until 31 December 2024) is hereby included.

It is hereby stated the Liquidity Contract remains temporarily suspended since November 19, 2024, as a result of the share buyback program approved by the Company, (the "Buyback Program") as communicated through Inside Information dated November 18, 2024 (registration number 2474).
